



Hold Harmless Agreement and Limits of Liability

PLEASE READ FULLY & COMPLETE AREAS IN COLOR ●

For reasonable consideration given, the undersigned hereby acknowledges, consents and agrees that in no event shall Big Woods Goods, LLC, or any of its managers, shareholders, officers, heirs, consigns, and/or employees be held responsible or liable for any acts or omissions, or for any indirect, direct, incidental, special or consequential damage, injuries or costs whatsoever, resulting from or related to the use or misuse of firearms or Archery on any of the shooting range facilities by the undersigned.

The undersigned also agrees and consents to hold Big Woods Goods, LLC harmless for any acts or omissions on the part of the undersigned as it relates to:

- The transportation of firearms and/or archery equipment to and from the facility, and further certifies that the method used to transport said firearms and/or archery equipment conforms in all respects to the laws of the State of Georgia.
- The direct or indirect handling of firearms and/or archery equipment.
- The use of firearms and/or archery equipment while participating in live-fire events on any of the ranges.

The undersigned further acknowledges and admits that Big Woods Goods, LLC has taken every precaution necessary to insure the undersigned's safety during your visit to its facility and that Big Woods Goods, LLC shall not be held liable for any act or omission outside its jurisdiction or control, or directly related to negligence on the part of the undersigned. The undersigned further acknowledges receipt and understanding of the safety rules of this facility and agrees to abide by them at all times while at the Big Woods Goods, LLC facility.

The undersigned hereby affirms that they are knowledgeable of the firearms and ammunition and or the archery equipment they will use while visiting the range and that they have received, read, understand, and will comply with posted and published rules and regulations as it relates to the use of said facilities, and/or that they have been informed that basic firearms/archery education courses are available to any user who is unfamiliar with shooting as a recreational activity. Further, the undersigned acknowledges that failure to comply with the rules could result in their expulsion from the range and the temporary and/or permanent loss of range privileges.

The undersigned hereby expressly acknowledges that the management of Big Woods Goods, LLC reserves the right to refuse access to any person(s) for any reason that might result in a safety violation, damage to the facilities, or who, in their sole discretion, may become a safety hazard, i.e., they demonstrate unsafe firearm/archery handling practices, a lack of proper training, they use an unsafe firearm, they become loud, boisterous or disruptive, fails to wear the minimum footwear (sandals), or any other act or omission that is contrary to established criteria for operating a safe and efficient shooting range.

The undersigned affirms, by their signature, that they have refrained from being under the influence of alcoholic beverages or drugs while on property owned and/or controlled by Big Woods Goods, LLC. Further, the undersigned further affirms that they understand the consumption of drugs or alcoholic beverages is expressly prohibited on Big Woods Goods, LLC property, and that any person(s) who, strictly by our observations, appear to be under the influence of alcohol or illicit drugs or emotionally unstable, shall be denied access to any part of the facility.

The undersigned does hereby affirm that they alone shall assume full responsibility for their own actions while visiting the Big Woods Goods, LLC facility and that any injury sustained either by their act or omission directly attributed to the lack of training, or careless acts shall be borne by themselves.

The undersigned does hereby affirm that the ammunition that they will use in their firearm(s) has been properly loaded, either by a licensed manufacturer or if the ammunition has been hand loaded by themselves that it was done so by following established criteria as contained in leading reloading manuals; and further that said reloads meet or exceed factory specifications regarding safety. Further, that the undersigned understands **that they MAY NOT USE STEEL OR ALUMINUM CASE, ARMOR PIERCING, STEEL CORE, INCENDIARY, or TRACER AMMUNITION** and that if the undersigned does, any damages resulting such use may be billed directly to the undersigned; i.e., damage to range structures or fires.
